

SPECIAL CITY COUNCIL MEETING

NO. 2009-26

NOVEMBER 30, 2009

The Mayor and City Council of the City of Chadron, Nebraska met in special session in the City Hall Council Chambers at 234 Main Street on the 30th day of November 2009, at 5:00 o'clock p.m. The following individuals were present: Mayor Donny Grantham, Vice Mayor John Gamby, Councilmember Steve Duncan, City Manager Sandy Powell, City Clerk Donna Rust, Chief of Police Tim Lordino, Public Works Director Milo Rust, Zoning/Building Official Janet Johnson, City Attorney Adam Edmund, Finance Officer Melany Hughes. Also present were: Street Superintendent Terry Birnbaum, Parks/Cemetery Superintendent Scott Schremmer, Utilities Director Tom Menke, and Library Director Rossella Tesch. Absent: Councilmembers Rob Harvey and John Chizek.

Notice of the meeting was given in advance thereof by publishing notice in The Chadron Record as shown by the affidavit of publication filed in the City Clerk's office. Notice of the meeting was also given in advance to the Mayor and all members of the City Council and a copy of their acknowledgment of receipt of notice and the agenda is attached to the minutes and is filed in the City Clerk's office. Availability of the agenda was communicated in the advance notice and in the notice of the Mayor and City Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

The purpose of the meeting was to hold a workshop to review the proposed City Code as revised and updated. City Manager Powell highlighted the changes that were being proposed to update the Code. Discussion followed.

Mayor Grantham instructed the City Code, along with the proposed revisions to be put on the City's web-site. It was the consensus of those present that the three readings to approve the proposed ordinance would not take place until the first part of 2010.
